

INTELLIGENT MEMORY RoHS* Compliance Declaration

We, Intelligent Memory Limited, hereby certify that our IM DRAM modules and IM DRAM components containing RoHS in the parts description are in compliance with the European directive 2011/65/EU** and 2015/863/EU*** Restriction of the use of certain Hazardous Substances (RoHS) in electrical and electronic equipment (EEE) – recast and its amendments of the European parliament and of the council (RoHS 2.0 Directive).

The RoHS-conformity of our IM DRAM modules and IM DRAM components can be usually derived from the the device's part number, description and the manufacturer's data sheet.

The substances concerned are listed in Annex II of 2011/65/EU. The first version was released on 1st of July, 2011 and amending Annex II to RoHS Directive 2015/863/EU was released on 31st of March, 2015 in the Official Journal of the European Union.
